Campaigning for a homelessness funding system that works

The Autumn Budget and Spending Review

The funding cliff edge

The Government provide significant funding to the homelessness and rough sleeping sector through an array of grant funds as laid out in the Ending Rough Sleeping for Good strategy (2022). These funds, allocated by central government and often commissioned out at local authority level, are one of the main sources of income for support services and accommodation providers.

However, the vast majority of funding commitments made to relieve single homelessness are set to expire by April 2025, representing almost £1bn that is due to leave the market between now and April.

This precarity takes place at a time of increasing need, with bed spaces decreasing, all forms of homelessness rising, and the risk of increased flow onto the street caused by early prisoner release and rapid asylum processing.

The Government's budget timeline

On October 30th, the Chancellor Rachel Reeves will deliver the Autumn Budget. Within it, she will announce the finalised departmental budgets for this financial year and 2025/26 only. **The deadline for organisations to submit budget and spending review submissions is on September 10th.**

This will then be followed by a multi-year Spending Review in Spring 2025. Through this, Reeves will set out the Government's spending plans up until 2028/29.

Our asks

- To provide assurance to service providers and prevent the homelessness system from collapsing, at the upcoming Autumn Budget we will be calling for a one-year rollover of existing homelessness funding into 2025/26, including additional funding to enable inflationary uplifts to local authority commissioned contracts for homelessness services and accommodation projects.
- 2. As part of the multi-year Spending Review, we will be **calling for a systematic** review of all homelessness-related spending across government informing a commitment to developing and delivering a consolidated, ring-fenced homelessness funding system from 2026/27 onwards. This system should be based on our key principles for a homelessness funding system.

Member actions

Our asks will only be successful if the homelessness sector comes together and makes itself heard. Therefore, we are keen for our member organisations to support with three different activities.

1. Send a submission to the Treasury

The Treasury is accepting written submissions ahead of the Autumn Budget with the aim of commenting on government policy and suggesting new policy ideas to be considered in the upcoming Budget. Submissions are read by The Chancellor's team and help inform spending decisions. **The deadline to send a submission is 23:59 on Tuesday 10th September.**

Given the tight deadline, Homeless Link has produced a template submission which its members can use. The template outlines the funding cliff edge the homelessness sector faces and why it is imperative the Chancellor announces a one year roll over of homelessness funding, before launching a review of all homelessness funding. It also leaves space for organisations to add in their own data. **Send it before the deadline via** <u>this online form</u> **on the Treasury's website.**

2. Write to your local MP(s)

Pressure in Parliament is often key to achieving policy change. Therefore, during September, **we want as many of our members as possible to write to their local MP(s)** outlining why it is vital the Government announces a one year roll-over of homelessness funding in the Autumn Budget and urging the MP to write to the Chancellor on this issue and/or ask a Parliamentary Question on the subject. 3. Raise the alarm of the cliff edge in the media
