Local Government Association (LGA) Resources

The Local Government Association (LGA) is the national membership body for local authorities. They work on behalf of councils to support, promote and improve local government. Their 'Making Homelessness Strategies Happen' guidance can be found on [their website](#).

This guidance was published in December 2019 for local authorities, but may be useful for others considering strategic working. It sets out the legal duties for how councils must produce and publish their local homelessness strategy, including engagement with different stakeholders.

The guide sets out examples of different 'structures' for drawing up, agreeing and overseeing delivery of the strategy including a Strategy Steering Groups or Homeless Reduction Boards. The guidance concludes with five recommendations for LA's and there are some very helpful appendices including a [LA self-assessment checklist](#) for producing and delivering an effective strategy, [a template for a Homelessness Strategy Action Plan](#) and example [Terms of Reference for a Homelessness Strategy Steering Group](#).

Sefton Council's Homelessness and Rough Sleeping Strategy is included as a [good practice example](#).

MEAM (Making Every Adult Matter)

The MEAM approach is a non-prescriptive framework used by local partnerships across England to develop a coordinated approach to tackling multiple disadvantage in their local area. The MEAM framework can be found [here](#) and other resources are available on [their website](#).
